## 1 Who is responsible for the data processing and whom can I contact?

#### 2 What sources and data do we use?

#### 2.1 Data we have received from you

Categories of personal data	Explanations of the categories of personal data
Master data	If provided by you: e.g. name, salutation, date of birth, postal address, telephone numbers, email address, data on the company
Data protection law declarations	Declarations of consent to the processing of personal data; declarations on the withdrawal of consent given by you; declarations on the objection to the processing of personal data; declarations on the claiming of your rights to information, correction, deletion, restriction of processing, data transferability including the information that you provide us with when claiming your rights.

## 3 What do we process your data for (purpose of processing) and on what legal basis?

The legal basis of the processing is your granted consent under Article 6(1) (a) GDPR.

Purpose/legitimate interest	Explanation of the purposes
Provision of information	We use your data to inform you of the subjects requested by you. To this end, we regularly send you the information requested by you to the address details provided by you.

## 4 For how long are my data archived?

In the event of your consent, your personal data will be archived for so long until you withdraw your consent.

#### 5 Who gets my data?

Within the bank, those units get access to your data that need them to fulfil the above purposes of processing. Service providers involved by us and active on our behalf (contract processors) may be given data for these purposes.

#### 6 What are my data protection laws?

Each affected person has the right to information under Article 15 GDPR, the right to correction under Article 16 GDPR, the right to deletion under Article 17 GDPR, the right to limitation of processing under Article 18 GDPR and the right to data transmission under Article 20 GDPR. To exercise the above rights, you may contact the units specified under Item 1. In addition, there is a right to complain to a data protection supervisory office (Article 77 GDSG). The supervisory authority responsible for NRW.BANK is:

The State Officer for Data Protection and Information Freedom North Rhine-Westphalia (LDI NRW)

In addition, you have a right of withdrawal that is explained at the end of this document.

## Declaration of consent and right of withdrawal

I hereby consent that my above data are processed for the above purposes of NRW.BANK.

The above declaration of consent is voluntary and may be withdrawn at any time for the future. I have been informed that a refusal to consent or a withdrawal cannot have any detrimental consequences for me.

The withdrawal can be made formlessly and should be addressed to the unit in charge (see Item 1).

In the event of withdrawal, on receipt of my declaration of withdrawal my data with NRW.BANK will be deleted, unless we can prove reasons subject to mandatory protection for the processing, which outweigh your interests, rights and freedoms or the processing, serves the claiming, exercising or defence of legal claims.
